7. **MATERION YN CODI O'R COFNODION / MATTERS ARISING FROM MINUTES**

7.1 Diolchwyd i Cyng Evan Jones am wneud yr arolwg gweledol diwethaf yn y parc a chytunwyd i Cyng Rhian Jones wneud am y mis i ddod.
Yn dilyn arolwg gweledol Cyng Evan Jones, soniwyd bod y ddwy fainc concrit yn beryglus a bod angen symud y ddwy o'r parc mor fuan â phosibl, Cyng Evan Jones yn cynnig symud nhw o'r parc yn llwyr.
Cadeirydd i wneud ymchwil am y gost o adnewyddu'r seddu sydd ar y swings.
Cadeirydd i drosglwyddo'r manylion am y gwaith oedd angen eu gwneud yn y parc ar gyfer y Clerc i'w hanfon ymlaen i TTS am amcan bris.

CADEIRYDD / CHAIRPERSON

Cllr Evan Jones was thanked for carrying out the last visual park inspection and Cllr Rhian Jones was asked to carry out the next inspection.

Following Cllr Evan Jones visual inspection, it was mentioned that the two concrete benches in the park were in very poor condition and needed to be removed immediately. Cllr Evan Jones offered to remove from the park.

Chairman to make inquiries to the cost of replacing the seats on the swings.

Chairman to forward the schedule of works needed to be carried out in the park in order for the clerk to forward to TTS for a written quotation.

The following were nominated to attend the meeting, Cllr Arwel Jones, Cllr Catherine Hughes, Cllr Gwilym Jenkins, Cllr Evan Jones and the Clerk.

16. **EISTEDDFOD GENEDLAETHOL CYMRU 2020**
16.1 Trafodwyd y cais oedd wedi'u dderbyn trwy law Cyng Catherine Hughes o'r pwyllgor apêl, i weld a yw'r Cyngor Tref yn fodlon fod yng ngofal yr arian ychwanegol a fu wedi'u gasglu trwy ddigwyddiadau diweddar fel 'Strictly Caron Dancing' i harddu'r dref. Clerc wedi cysylltu am gyngor o Un Llais Cymru ac mae'n hollol iawn i'r Cyngor Tref wneud hyn ond i nodi byddai angen cadw fwy o gyfrifon am yr arian ychwanegol. The application received from the Appeal Committee, through Cllr Catherine Hughes, was discussed, if the council were willing to accept responsibility for the excess monies raised through various events like 'Strictly Caron Dancing' to decorate the town. Clerk had been in contact with the office of One Voice Wales and they could see no problem taking responsibility for the excess monies except that there would be additional work and accounting to accommodate for. All options were discussed and it was proposed by Cllr Evan Jones and seconded by Cllr Alun Owen to open a separate bank account to keep the excess monies for the decoration of the town. It would be discussed at the next meeting what the Councillors would like to see and put forward to the Appeal Committee their suggestions on how to decorate the town.

An auction would be held through the appeal committee on 22nd February 2020 in the Talbot Hotel.

The condition of the Gelli Gron garden, Pentre was discussed and it was agreed that Cllr Rhydian Wilson would talk to the owner of the garden and explain to him the poor condition of the steps leading up to the garden.
